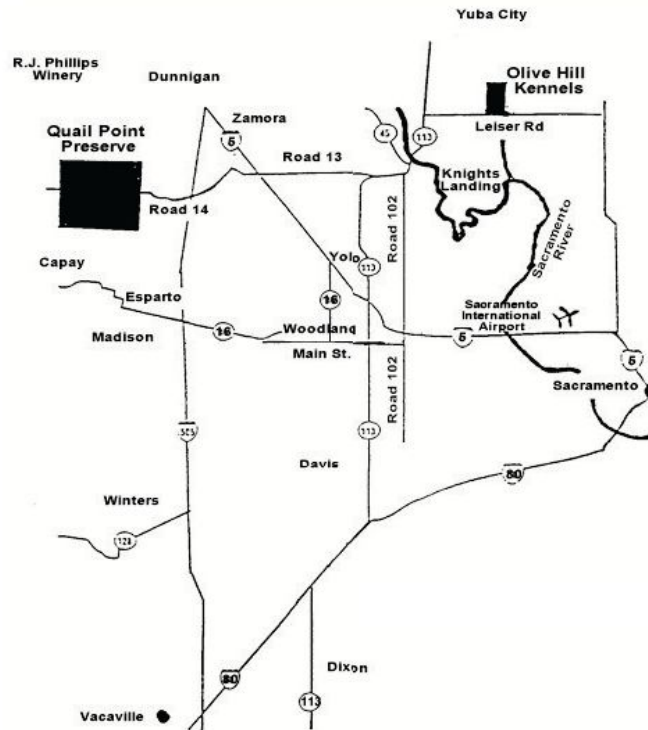

## Directions to Quail Point Hunt Club



**From the Bay Area** - From I-80 @ Vacaville, take the I-505 turnoff heading north toward Redding. 30 miles North of Vacaville, take the Rd. 14 turnoff. Turn left, heading West over the freeway. Clubhouse is 1/2 miles west of "505" on left, near bam.

**From Sacramento** - From Sacramento, take I-5 heading north. Take the "Zamora" turnoff; turn left heading west over freeway. Travel for 3 miles, cross over "505". Clubhouse is 1/2 mile west of "505" on left, near bam.

### Hotels:

Dunnigan 10 – 15 minutes north from Quail Point - California Motel and Motel 6,  
Woodland – 15 minutes south on I-5 – Holiday Inn Express, Valley Oaks Inn, and Econo Lodge  
Overnight camping allowed only in trailers, motor homes, or campers and at the clubhouse only. No hookups are available.
