All tests are single course with a bird field. A blank pistol must be fired in the Junior Hunt Test and for backfield birds in the Senior and Master Hunt Tests. Shotgun blanks will NOT be allowed in any test. AKC does not allow the use of pistols capable of firing live ammunition.

An article of orange clothing must be worn while in the field.

When you arrive at Quail Point please stop by the office and sign their waiver prior to proceeding to the hunt test.

Standard AKC rosettes to all dogs receiving a qualifying score.



# Directions to Quail Point Hunt Club



**From the Bay Area -** From 1-80@ Vacaville, take the 1-505 turnoff heading north toward Redding. 30 miles North of Vacaville, take the Road 14 turnoff. Turn left, heading West over the freeway. Clubhouse is 1/2 mile west of "505" on left, near barn.

**From Sacramento** - From Sacramento, take 1-5 heading north. Take the "Zamora" turnoff, turn left heading west over freeway. Travel for 3 miles, cross over "505". Clubhouse is 1/2 mile west of "505" on left, near barn.

#### Hotels:

Dunnigan 10 – 15 minutes north from Quail Point - California Motel and Motel 6, Woodland – 15 minutes south on I-5 – Holiday Inn Express, Valley Oaks Inn, and Econo Lodge Overnight camping allowed only in trailers, motor homes, or campers and at the clubhouse only. No hookups are available.
