Course And Birds

All stakes single course, with bird field except Open and Amateur Puppy. No birds released in Open and Amateur Puppy and no blank pistol will be fired. OGD, AGD and ALGD are all retrieving stakes with chukar, quail and/or pheasant to be used. OLGD is a non-retrieving stake with chukar, quail and/or pheasant. Derby is a non-retrieving stake, with chukar, quail and/or pheasant. AKC tracking collars are not allowed. Blaze orange must be worn in all stakes. Anyone using an ATV to run dogs per ADA must submit a letter of AKC approval and have proof of private insurance to the secretary with your entries and to Quail Point management before running any dogs.

- *Limited overnight camping allowed only in trailers, motor homes, or campers and at the clubhouse only. No hookups available.*
- Water is limited so be sure to bring enough for you and your animals.
- Although we have ordered sunshine, we hope for dry weather, December can bring rain, wind, cold and other weather. Please be prepared for whatever weather the heavens may bestow upon this event.

Directions:

- 29625 County Road 14, Zamora, CA (Mapquest may call this Esparto)
- **Directions from the Bay Area:**
 - From I-80 at Vacaville, take the I-505 turnoff heading north toward Redding. 30 miles north of Vacaville, take the County Road 14 turnoff. Turn left, heading west over the freeway. Clubhouse is 1/2 mile west of "505" on the left, near the barn.
- **Directions from Sacramento:**
 - From Sacramento, take I-5 heading north. Take the "Zamora" turnoff, turn left heading west over the freeway. Travel 3 miles, cross over "505". Clubhouse is 1/2 mile west of "505" on the left, near the barn.

Hotels:

- **Dunnigan** – 10 to 15 minutes north from Quail Point - California Motel, Motel OYO and Best Western
- **Woodland** – 15 minutes south on I-5 – Valley Oaks Inn

Rules of Quail Point Hunt Preserve

1. **NO SMOKING** on property, except for **INSIDE** your enclosed vehicle.
2. Hunters must park in designated parking areas and are **NOT** permitted to drive in the fields.
3. Overnight camping allowed only in trailers, motor homes, or campers and at the clubhouse only. No hookups available.
4. **NO HUNTING** allowed on the property unless an authorized agent of Quail Point Hunting Preserve is on the property.
5. Show common courtesy among others. Do not cut in front of others. Do not shoot a crossroads or hills where the view is not clear. No hunting when the fog is dense enough to be unsafe. Guns should be on "safety" while hunting in the field or walking on the Sporting Clays Course. No loaded guns in vehicles or the Clubhouse area. Please strictly adhere to all hunter safety guidelines.
6. Members/hunters are expected to stay on club property, which is clearly marked. **DO NOT CROSS ANY FENCE LINES!** To do so you are trespassing onto neighbor's property.
7. Safety areas are well marked. No shooting into a safety area!
8. No shot size larger than 6 allowed. No high base shells.
9. Everyone **MUST SIGN IN** and **OUT EACH DAY AT THE CLUBHOUSE DESK.**
10. **HUNTER ORANGE MUST** be worn at all times while hunting. A hat and/or vest are required. Safety glasses are recommended. Hats, vest and glasses are available at the clubhouse desk.
11. No alcoholic beverages are permitted while hunting or on the course. Anyone drinking alcohol or causing disturbances will be discharged from the Club.
12. All members/hunters shall make every effort to find dead or wounded birds.
13. Do not pluck or draw birds in the field. Do not litter the fields with cans, bottles, shell casings etc. Please help keep the premises clean! Please pick up spent shell casings.
14. All dog feces and waste must be removed from the parking area.
15. **IMPORTANT NOTE:** Quail Point Hunt Preserve requires a separate liability release be signed by all persons attending this event; handlers, guests, committee members and judges will all be asked to sign this document upon arrival.
